Country Member	Any member who is not ordinary resident, nor ordinarily employed, nor carries on business or practice, within a radius of 64 kilometers of the Durban City Hall, will be classified as a full country member .Country members can play a maximum of 12 rounds of golf at members rate. Senior Member	Those members, who have applied for special membership, provided the applicant is a member for 20 years or more and over 65 years of age or is a member for 25 years or more and over 62 years of age.	R3 648.00

Senior Lady Member	Those female members, who have applied for special membership, provided the applicant is a member for 20 years or more and over 65 years of age or is a member for 25 years or more and over 62 years of age.	R3 648.00
Senior Lady Member with Golf	A Senior Lady member as above who has elected to take up the golf option	R3 933.00
Senior Country Member	Those Country members, who have applied for special membership, provided the applicant is a member for 20 years or more and over 65 years of age or is a member for 25 years or more and over 62 years of age. A maximum of 12 rounds can be played at members rate	R1 368.00

Life Member	All members who were admitted as life members prior to 4 March 1963, and those members who have completed 50 years of membership as Full, Associate Special Members and/or Senior members. For the purposes of determining whether a person has completed 50 years of membership, periods of ordinary membership, student membership and senior membership as applied prior to the date on which this Constitution came into effect shall be considered to be Full, Associate and Senior membership in terms of this Constitution, as the case may be.	
Honorary Member	<p>Any of the following persons may be admitted as honorary members by the Board:-</p> <ul style="list-style-type: none"> • Persons engaged in any match, competition or tournament held at the Club; • A member of a committee or official of the sports associations to which the Club is affiliated, whilst such committee member or official is at the Club on official business; • Presidents and captains of similar Clubs who have introduced themselves to the Chief Executive Officer; • Persons who are considered by the Board by reason of their office or position or otherwise to be appropriate to be admitted as Honorary Members. <p>Honorary membership shall be for such period as the Board may determine and may be cancelled at any time by the Board.</p>	
Honorary Life Member	Members of other persons who have, for services rendered to the Club, been elected as such by a three-fourths majority at a General Meeting of Members.
