LADY MEMBERSHIP

Lady members have the option of taking the limited golf option; the only restriction is that the members who select this option will be restricted from playing on Wednesday, Thursday, and Saturday afternoons. In order not to gender discriminate ladies wishing to take the full golf option, will have to apply for full membership.

BENEFITS OF THE GOLF OPTION

1. The full golf option allows you to use the golf course at any time at a greens fee rate of R155.00 per 18 holes.
2. The limited golf option allows members to play golf at a greens fee rate of R155.00 during our off peak times and R250.00 during our peak times per 18 holes. Our peak times are Wednesday and Thursday afternoons and the whole day Saturday.
3. A Social Member has use of all our Club Facilities excluding Tennis, Squash, Bowls or Golf, and can therefore not be handicapped at the Club. Visitor's golf rates will apply during off peak only.

Extracts from the constitution Entrance fee and deposit payable

An amount equivalent to 10% of the entrance fee shall be paid by the applicant when his or her application for membership is lodged. Such advance payment of entrance fee shall not be refundable nor shall it bear interest, but the Membership Committee shall have the right to authorize a refund at its discretion. Upon election to membership, the applicant shall become liable to pay the difference between the entrance fees less any advance payment already made.

A member changing to a class of membership which has a higher entrance fee than the entrance fee/s paid by the member to that date, shall be obliged to pay the difference between the entrance fees payable at that time for the relevant categories.

If a member fails to pay an account for any amount due to the Club within 30 days after the date endorsed upon the account, such member shall be liable to pay interest on at the published legal rate.

Liability of proposer and seconder

All applicants for membership must be proposed by one member and seconded by another, both of whom must be members of at least three years' standing and entitled to vote at a general meeting. The applicant must be personally known to the proposer and seconder. No member may propose and/or second more than six applicants during any one calendar year.

The proposer and seconder of each applicant shall be jointly and severally liable for the entrance fee and first annual subscription of the applicant whom they have proposed and seconded, notwithstanding that his or her membership may have ceased due to non-payment in terms of clause 6.15 of the Constitution.
